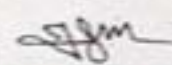

- (૧) જે કોલેજમાં જે વિષયના જે તે વિભાગમાં અધ્યાપક સેવા આપતા હોય તે જે કોલેજના સેવાકામને શ્રેયાનતાની ગણતરીમાં ધ્યાનમાં લેવા.
- (૨) ૧. માં સૂચવેલી ગણતરી વ્યાખ્યાતાના જ હોદ્દા પરના સેવાકાર્યને ધ્યાનમાં લઈ કરવી.
- (૩) જે તે વિષયના વિભાગીય વડા બનવા માટે એકથી વધારે અધ્યાપકોના ઉપર (૧) અને (૨) માં દર્શાવ્યા પ્રમાણે સેવા-કાળ સમાન થતો હોય તો જે તે વિષયમાં વિભાગના વ્યાખ્યાતા એક જ કોલેજમાં જે તે વિષયમાં / વિભાગના ટ્યુટર / ડેમો-સ્ટ્રેટર તરીકે સમાન તારીખ કરતા વહેલા જોડાયા હોય તે અધ્યાપક શ્રેયાન ગણાશે અને વિભાગીય વડા થશે.
- (૪) ટ્યુટર / ડેમો-સ્ટ્રેટર તેમજ જે તે વિષયમાં / વિભાગમાં વ્યાખ્યાતાનો સેવા - કાળ સમાન થતો હોય તો તે કિસ્સામાં જે અધ્યાપકની જન્મ તારીખ વહેલી હોય તે શ્રેયાન ગણાશે અને વિભાગીય વડા થશે.

- (૫) તા. ૦૯-૦૫-૧૯૮૦ એટલે કે સુધારેલો સ્ટેટ્યૂટ - ૧૨૧ અમલમાં આવ્યો તે પહેલા જે અધ્યાપકો જે હેસિયતમાં જે તે વિષયના વિભાગીય વડા તરીકે નિમણૂક પામી તે જ હેસિયતમાં જે તે વિષયની અભ્યાસસમિતિના સભ્ય તરીકે હજી પણ ચાલુ રહ્યા હોય તેઓને પદે ચાલુ રાખવા અને ઉપર જણાવેલ શ્રેયાનતાના માપદંડે એમના હોદ્દાને કોઈ પણ વિપરીત અસર ન થાય તે જોવું.
- (૬) જ્યાં સૌથી સિનિયર - મોસ્ટ શિક્ષક પાંચ વર્ષ નો શૈક્ષણિક અનુભવ ધરાવતા ન હોય ત્યાં તેમના પછીના શિક્ષક, જે આવા અનુભવ ધરાવતા હોય તો વચગાળાના સમય માટે સ્ટેટ્યૂટ - ૧૨૧ (૩) (સી) અન્વયે, અભ્યાસસમિતિમાં જઈ શકશે, પરંતુ પોતાની કોલેજમાં પોતાના વિભાગના વડા તરીકે કે ખરેખરા સિનિયર - મોસ્ટ શિક્ષક હોય તે જ હેડ ગણાશે અને એમને પાંચ વર્ષનો અનુભવ મળતાં તેઓ અભ્યાસસમિતિમાં જવા માટે હકદાર રહેશે અને જે સિનિયર મોસ્ટ નથી તે આપોઆપ બોર્ડના સભ્યપદેથી ફારેગ થયેલા ગણાશે.
- (૭) સિનિયર મોસ્ટ અધ્યાપક, માટે વિભાગીય વડા તરીકે કામ કરવું ફરજિયાત રહેશે અને તે એમની ફરજનો ભાગ ગણાશે.

આ અર્થઘટન સ્ટેટ્યૂટ - ૧૨૧ (૩) (સી) ની નોંધમાં સમાનતર એવી શ્રેયાનતાની જોગવાઈનું જ છે., સ્ટેટ્યૂટની આ ઉપરાંતની જોગવાઈ યથાવત્ રહે છે.

NOTIFICATION :

It is hereby notified that pursuant to the powers conferred under Section 3 (6) of the South Gujarat University Act 1965, the assent of the Chancellor of the amended Statute 121, as passed by the Senate at its meeting held on 18/19-11-1979, has been conveyed to this University under letter dated 09-05-1980 from the Office of the Secretary to the Governor of Gujarat.

The text of the amended Statute 121 is given below :

STATUTE - 121 :

- (1) The Board of Studies enumerated in the Statute 120 shall be constituted for the subjects taught in the University or in the affiliated colleges and recognized institutions as prescribed in the Section 26 of the Act.
- (2) "Head of the University Department" under Section 26 (2) (i) shall mean a Professor or a Reader designated as such in the Department of the subject concerned. Provided that it is permissible for the Vice-Chancellor to treat any additional teacher not below the rank of a Reader as Head of the University Department for the purpose of Section 26 when there are more than one Board of Studies in the subject in which the Department is providing instruction.
- (3) Heads of the Department in the Special subjects taught at the degree level in the affiliated colleges and recognized institutions under Section 26 (2) (ii) shall include :
 - (a) Heads of the Department designated as such in the subject taught as a Special or Principal or major or optional (as in Commerce Faculty) subjects in the Degree Class.
 - (b) Heads of the Departments designated as such in subjects taught as a compulsory subject in the faculties of Medicine, Law and Rural Studies.
 - (c) Heads of the Departments designated as such in the subjects taught as compulsory subjects in the Final Year of the Degree Class in the Faculties of Arts, Science, Commerce, Education and Technology including Engineering.

Note : For the purpose of this Clause (3) only such persons who are senior most teachers in the subject on the staff of the college and are having a teaching experience of at least five years in the Degree Classes shall be designated as the Head of the Department for the subject concerned in the affiliated colleges.

- (4) In case of a subject not taught as a compulsory subject at the final year of the degree class or a special subject at the degree level, the Syndicate may appoint an Ad-hoc Committee for such subject or group of allied subjects on the recommendation of the Dean of the respective Faculty.

(Note : Please refer enclosed Uni. Circular No. S/5429 Dt. 10-05-1990 regarding interpretation of Statute - 121)

STATUTE - 122 :

- (1) Not later than the 1st January every three years, the Registrar shall request the (i) Heads of University Departments, (ii) Principals of affiliated Colleges and (iii) Heads of recognized Institutions in the University area to furnish to him within ten days from the receipt of the letter, names (with their designation) of heads of departments if any, in special and / or compulsory subjects taught at the degree or post - graduate level as the case may be in their department of institution.
- (2) If any change is made there in during a triennium, the Head of the University Department or the Principal of the College or the Head of the recognized Institution shall inform the Registrar forthwith about the change and the Registrar, immediately on receipt of this information shall inform Chairman of the Board concerned about the change in the membership of his Board and shall also take necessary consequential steps for filling up any vacancy arising for the change.

SECTION 26 :

- (1) There shall be a Board of Studies for every subject or group of subjects as may be prescribed by the Statutes.
- (2) Subject to the provisions of sub-section (3) each Board shall consist of :
 - (i) The head of the University department, if any, in the subject;
 - (ii) Heads of the departments in the special subjects taught at degree level in the colleges and recognized institutions;
 - (iii) Not more than three experts in the subject co-opted by the Board;
- (3) Each Board shall consist of at least four members;
 Provided that where the number of members is less than four, the Vice-Chancellor shall nominate such number of members as may be necessary to make up the deficiency, subject, however to the condition that the total number of co-opted and nominated members shall not exceed three.
- (4) The Chairman of the Board shall be elected by the members of Board, from amongst the members specified in clause (i) and (ii) of sub-section (2). The person to be elected as Chairman shall, as far as possible, be a person qualified to teach Post-graduate courses.
- (5) The power and duties of a Board of Studies shall be as follows :
 - (i) To recommend courses of studies in the subjects;
 - (ii) To recommend and prescribed where necessary, books for study in the subject;
 - (iii) To recommend programmes for extension services and research in the subject;
 - (iv) To recommend organization of seminars, refresher courses and workshops to the Dean of the Faculty;
 - (v) To recommend programmes for experiments and research in the courses of studies prescribed in the subject;
 - (vi) To recommend schemes for preparation and translation of books in the subject and suggest bibliography of books of study;
 - (vii) To frame and propose Regulations pertaining to the courses of studies and examinations in the subject;
 - (viii) To review periodically the terminology current in the subject; and
 - (ix) Such other power and duties as may be prescribed by the Statutes,
- (6) A Board of Studies shall meet at least twice during an academic term as determined by Ordinances.
- (7) The term of Office of a Board of Studies shall be three years.
